Inaugural US-Qatar Strategic Dialogue

Washington, DC January 2018

The first ever strategic dialogue, held in Washington, DC, established a shared vision of the bilateral partnership. The strength of the defense relationship was highlighted, especially Qatar's investment in state of the art military systems which supports over 100,000 American jobs. The US and Qatar are committed to boosting trade and signed agreements to enhance cooperation and investment in the fields of trade, technology, and energy.

Chicago, IL June 2019

In June, USQBC hosted a series of engagements in Chicago, IL for Qatar's Consul General inn New York, Nasser Allenqawi. The events ranged from cultural (in partnership with the Qatar-America Institute), to business and networking. USQBC hosted a lunch with the support of the Illinois District Export Council and the Chicago Regional Growth Corporation, welcoming over 40 representatives from the Chicago-area private sector. This engagement is part of a series of trips USQBC plans to take around the US with Qatar's Consul Generals.

Webinar: Doing Business in the United States

US & Doha July 2019

USQBC worked with Dorsey & Whitney LLP to host a webinar focused on how to do business and invest in the United States. Lawyers from Dorsey & Whitney provided inside knowledge into the US business climate, rules and regulations for establishing a company, and the ins and outs of investment laws in the US. The webinar targeted Qatari companies who may have an interest in the US market and is part of USQBC's mission to further enhance the bilateral trade relationship.
